Bring your own practice clothes, shoes and socks.

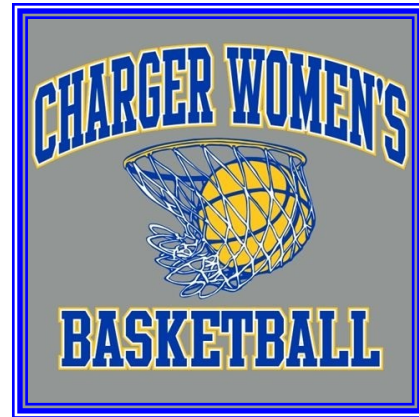
Shoes worn outside are not allowed on the gym floor.
